



**Contract and Health Warranty**

This agreement is between Probreeders, LLC (Sellers) and \_\_\_\_\_(Buyers).

This is a legally binding contract and is agreed as follows:

**1. DESCRIPTION OF DOG**

The dog sold pursuant to the terms of this agreement is as follows:

**CONDITIONS OF SALE**

Seller agrees that, at the time of delivery, this dog is in good health.

**The following conditions apply to all sales:**

a – The Buyer has Three (3 ) days, (72 hours) from the time of receipt of dog to have the dog examined by a licensed veterinarian. Should the dog be found to be in poor health of a serious nature, (such as a debilitating congenital defect), Buyer agrees to return dog to seller at Buyer’s expense. Seller will provide Buyer with a replacement dog of equal value from another litter, or a full refund of the purchase price of the dog will be made. Shipping fees will not be refunded. Any request to return the dog to the Seller for a full refund must be made within this time period and may only be requested should the dog prove to be sick upon arrival. Proof of examination must be provided to the Seller and the Seller retains all rights to have the puppy examined by his own vet or a third disinterested party if necessary. If the puppy is not taken to a licensed veterinarian within the specified 72 hour time period, this warranty is null and void.

b – A warranty against any debilitating, life altering genetic defect is provided for 24 months after sale of dog. Any warranty for hip dysplasia will be terminated should the dog be allowed to become overweight or any undue stress or strain be allowed to be placed on developing joints, again determined by Buyer’s veterinarian records and by Seller’s veterinarian or by arbitration of a neutral third party.

c – This warranty does not cover such issues as: viral illnesses, infections, improper bites, hernias, hypoglycemia, giardia, coccidiosis, or tick or vector borne disease. It also does not include any illness due to ingestion of foreign objects or inappropriate foods, chemicals, or physical injury. Seller is not responsible for any veterinarian fees, medical expense, human allergies, training difficulties or behavior problems.

d – No warranties or guarantees, expressed nor implied, are made under this contract except as stated.

e – Buyer agrees to maintain this dog in good health, provide routine preventative health care, including, but not limited to: vaccinations, internal and external parasites, preventative medications, annual examinations, etc according to AVMA guidelines. All veterinary medical records must be provided to Seller if requesting refund or replacement. If any of the above preventative care has not been provided, health warranty will be considered null and void.

f – Should any litigation arise regarding the puppy for any reason, the Purchaser agrees to allow Seller determination of venue.

**FULL AND FINAL AGREEMENT**

All parties agree that this writing represents the entire Agreement between them and that no other representations have been made regarding the dog described in paragraph one, above.
