In the event of the unexpected death or terminal illness of your puppy, your deposit will be applied to a puppy of your choice from the current litter, if any are available, or from the next available litter. The balance of \$_____ is due not later than 4 weeks after the birth of the puppy. If shipping charges are applicable, these will be due at this time, as well.
